**CAREFULLY READ TERMS PRIOR TO PARKING.
PARKING CONSTITUTES CONTRACT WITH OWNER AND CONTRACTOR.
DO NOT PARK IF NOT IN AGREEMENT WITH CONTRACT TERMS.**

Posted parking fees must be paid in advance.

Parking in lots signifies you accept: All posted terms, conditions and requirements and applicable fees, fines, and penalties. This contract may affect your legal rights.

Violations issued or vehicles impounded for: failure to pay in advance, exceeding posted time, having multiple unpaid parking notices, and improper parking. Additional late fees will apply when fees are not paid within 14 days.

- \$40 per parking violation
- \$25 late fee after 14 days unpaid

Parking Operator reserves right to refer unpaid fees to collection agency.

Secure your vehicles and valuables. Port and Operator not liable for car or contents.

Violation Name	Violation Type	Enforcement Rule
Failure to Pay Launch Fee	Failure to pay in advance	Vehicles with attached trailers parked at the Boat Launch are required to pay for their launch.
Failure to Pay Parking Rate	Failure to pay in advance	The vehicle was found to not have a valid payment after the first two hours of free parking.
Failure to Pay Event Rate	Failure to pay in advance	Vehicle was found to have not have a valid payment on an event day. During events, no free two hours are given.
Exceeded Posted Time Limit	Exceeded posted time limit	Various levels of timed access are displayed on signs at the Port of Everett. If a vehicle stays in a stall in a zone that displays this timed access for more than the posted time, a citation will be given regardless of previous payments.

Exceeded Posted Time Limit (96 Hours)	Exceeded posted time limit	Slipholders are allowed to park in the same stall continuously for only 96 Hours, unless otherwise setup by LAZ Parking. This citation is given only if a vehicle parks more than four days in a row as a slipholder.
Parked without Permit	Improper parking	Permits are required from LAZ Parking to park in zones labeled with Signs that say that a permit is required to park there.
Unauthorized Parking	Improper parking	Vehicle is parked outside the rules of a parking area or of the rules allowed by the Port of Everett. A great example is someone parked in a handicap stall if they do not have a handicap permit.
Improperly Parked Vehicle	Improper Parking	Vehicle is not parking within a stall or outside of normal parking behavior. For example,

		<p>parking in a fire lane, parking across several stalls, parking in an area that is not marked as a stall.</p>
<p>Unattached Trailer</p>	<p>Improper Parking</p>	<p>Trailers are not allowed to be unattached on Port of Everett Property. They are a safety hazard and easily stolen. The Port doesn't abide behavior that is unsafe and can lead to missing property.</p>
<p>Expired Tabs</p>	<p>Improper Parking</p>	<p>The Port of Everett requires all vehicles that park at the Port of Everett but street legal. This means that all vehicles at the Port of Everett must meet all the legal requirements for use on ordinary roads. This includes registration being updated every year.</p>
